Program Background

From the 2019 legislative session, Assembly Bill 489 created the Grant Matching Fund (GMF) pilot program to provide matching funds to state agencies, local governments, tribal governments, and nonprofit organizations applying for federal and non-governmental organization grants. Senate Bill 528 of the 2019 session appropriated \$1 million to fund the grants awarded by the pilot program. The pilot GMF was approved by the Interim Finance Committee in December 2019 and launched in January 2020. Due to the COVID-19 public health crisis, the program stopped accepting applications in April 2020.

Assembly Bill 445 of the 2021 Nevada legislative session extended the GMF, renaming it to the Grant Matching Program (GMP) and narrowing it to fund matches for federal grants only. An appropriation of \$1 million was approved to fund the Grant Match Account annually beginning in state fiscal year 2022. The balance of funds remaining at the end of an even year, rolls over to the next year. In odd years, any uncommitted funds without a Letter of Commitment from the Office of Federal Assistance revert back. As of July 1, 2022, the permanent program is administered by the newly formed Office of Federal Assistance.

Required Reporting

As required per NRS 223.498, the Nevada Governor's Office of Federal Assistance is submitting the below information by January 1, 2025, to the director of the Legislative Counsel Bureau for transmittal to the Legislature summarizing the GMP program.

NRS 223.498 states:

On or before January 1 of each odd-numbered year the Director of the Office shall prepare and submit to the Director of the Legislative Counsel Bureau for transmittal to the Legislature a summary report for the Program detailing:

- 1. The number and purpose of grant requests received from state agencies, local agencies, tribal government and nonprofit organizations;
- 2. The number and purpose of grant requests approved, and the amount of money awarded from the Grant Matching Account created by NRS 223.492 to each approved grant request applicant; and
- 3. The amount of federal grant funding received by each grant applicant as a result of receiving money from the Grant Matching Account.

Program Updates

The Grant Matching Program is continually improving to provide better service and maximize efficiency. Below are the updates made to the program since 2023:

1. Eligibility Checker



To provide faster service to our stakeholders, all applicants must complete a nine (9) question eligibility checker to see if the project being proposed qualifies for the Grant Matching Program. The questions come directly from the NRS. The Eligibility Checker takes on average 1.5 minutes to fill out. The applicant gets immediate results.

When a project is eligible, a congratulation screen pops up with a detailed list of items needed to fill out the application and the link to the application. Applicants are encouraged to print the list and gather the documents to save the applicant time when filling out the application.

2. Extended the Period of Eligibility

Prior to June 30, 2024, applicants who had received the Notice of Grant Award (NoGA) were not eligible for the program. Starting July 1, 2024, the period of eligibility was extended to include before the Notice of Grant Award (NoGA) was received AND up to 90 days after the NoGA has been received. The intention is to preserve a federal award when a previous match commitment fails to provide the promised match. Rather than the award being returned due to the inability to fulfill the match requirement.

3. The Open Application Period Updated

To provide a consistent open application period year over year and not lose application momentum, the open application period is from July 1st to June 1st of every year. This allows the last 30 days of a fiscal year to process any outstanding applications and issue a Letter of Commitment which locks the funds.

4. The Grant Payment Period Updated

To provide consistent payment periods year over year and account for fluctuations in rollover periods (even fiscal years where unexpended funds roll over to the next year's balance) vs non-rollover periods (odd fiscal years where the funds are used or lost). The grant payment period is from September 1st of each fiscal year to June 30th of each fiscal year.

Independent Review Application Delivery

Previously the whole application was emailed to independent reviewers in pieces. To make it easier for the reviewer to examine the application and to protect the applicant's private fiscal information, reviewers are given temporary access to the application and scoring sheet on the State's servers. The application is in one pdf file with a table of contents that helps the reviewer find the item they need to review.

This has reduced the amount of time a reviewer needs to examine the application from over an hour on average to less than 30 minutes. When the review is complete, access to the file is removed.

6. Independent Reviewer Experience Surveys



To continually improve the Independent Reviewer Experience, once a reviewer has completed their review, a reviewer experience survey is sent. The survey asks the reviewer to rate their experience, how long the review took to complete, if they would like to review again and any suggestions, they believe would make the experience easier.

The survey revealed three specific pinch points that have since been resolved: a table of contents was needed for the review packet; the time spent to review dropped significantly after the table of contents request was implemented, and MAC users had difficulty with their access link requiring work arounds.

7. Letters of Commitment & Unexpended Funds at the End of Biennium

The definition of what gets returned at the end of the odd year in each biennium was clarified to honor Letters of Commitment issued by the Office of Federal Assistance. Any unexpended funds not committed in a Letter of Commitment will revert to the general fund at the end of each odd year. This change protects awardees who are working through a federal grant negotiation, so they do not lose the match required to get the whole grant.

Summary Report

Grants and applicants had to meet certain eligibility criteria upon a technical review by the GMP Administrator to apply for the Grant Matching Program (GMP) match assistance. Purpose: The Federal Transit Administration (FTA) announces the opportunity to apply for a total of \$1,936,000 in Fiscal Year (FY) 2023 Public Transportation Innovation funds in competitive cooperative agreement awards for projects that enhance mobility innovations for transit. Funds will be awarded for projects that advance emerging technologies, strategies, and innovations in travel-centered mobility in two distinct areas. Of the total available funds, \$968,000 is available for projects to accelerate innovations that improve mobility and enhance the rider experience with a focus on innovative service delivery models, creative financing,



novel partnerships, and integrated payment solutions. Another \$968,000 is available for projects to develop software solutions that facilitate the provision of integrated demand-response public transportation service that dispatches public transportation fleet vehicles through riders' mobile devices or other means.

Purpose: The purpose of the Promise Neighborhoods (NP) program is to significantly improve the academic and developmental outcomes of children and youth living in the most distressed communities of the United States, including ensuring school readiness, high school graduation, and access to a communitybased continuum of high-quality services. The program serves neighborhoods with high concentrations of individuals with low incomes; multiple signs of distress, which may include high rates of poverty, childhood obesity, academic challenges, and juvenile delinquency, adjudication, or incarceration; and adverse childhood experiences; and also serves schools implementing comprehensive support and improvement activities or targeted support and improvement activities.

Status: Letter of Commitment (LOC) issued for \$50,000.00 on November 6, 2024, pending Notice of Grant Award (NoGA). Applicant has not been notified if they won the grant. The federal funder has not indicated an award announcement date.



3. Totals of Federal Grant Funding Received Due to the Grant Matching **Program**

As a fund of last resort, the Grant Matching Program enables stakeholders to pursue federal grants where the stakeholder has exhausted all other means of match. Below are the totals of the federal grant dollars brought into the State of Nevada as a result of the Grant Matching Program. For the applicants that have been awarded to date with funds either expended or obligated in support of federal projects, the GMP has a current 13:1 ratio, exceeding the 2:1 as set forth in NRS. For every \$1 that Nevada has committed to federal funding there has been a return, on average, of \$12.85.

Conclusion

In the last biennium and first half of state fiscal year 2025, the Governor's Office of Federal Assistance (OFA) proved the value of Grant Matching Program via solid results and an impressive rate of return on the investment. The law requires the Grant Matching Program provide at least



\$2 of federal grant dollars for every \$1 invested. In diligently supporting our stakeholders, the State of Nevada is obtaining more federal grant dollars, increasing our share of available federal grants and maximizing federal assistance.

The Program is experiencing growth in demand and quality applications received. Ineligible applicants receive eligibility results immediately before filling out the application via the new eligibility checker - saving staff and applicant's time. Internal processes are under continuous improvement resulting in faster processing times and better tracking systems for pre-award and post-award activities. The positive program improvements are guided by an invested leadership structure with gift for team building.

With the increase in program demand and the dollar value of requests rising, GMP has a growing challenge of leveraging the 1-million-dollar allocation per year with larger match demands with the upcoming federal opportunities.

While other states ask how we do it, we know there is still much to be done to educate our stakeholders about the Grant Matching Program and streamline the process to better enable stakeholders to obtain federal grant dollars for Nevada. However, it is a start we can all be proud of.
