Department Overview – Who Are We Today?

The Governor's Office of Federal Assistance was created with the passage of AB445

 Transitioned on July 1, 2022, from being the Office of Grant Procurement, Coordination and Management (Nevada Grant Office), within the Department of Administration

Department Overview – Who Are We Today?

AB445 directs the Office of Federal Assistance to do the following:

- *Identify Methods for:*
 - Expanding federal assistance;
 - Streamlining the process for the acquisition of federal assistance;
 - The effective administration of grants;
- Identify Opportunities for:
 - Coordination between state agencies, local agencies, tribal governments and nonprofit organizations to avoid duplication and achieve common goals;
 - Improvement of tasks in the administration of grants and maximize the amount of federal assistance received by the State;
 - Performance metrics and targets relating to obtaining and maximizing federal assistance;
 - Best practices for responsiveness to grant opportunities

Department Overview -Who Are We Today?

AB445 directs the Office of Federal Assistance to do the following:

- The creation and posting of a State Plan for Maximizing Federal Assistance
- The administration of the Grant Matching Program (formerly a pilot program)
- Oversee and provide support to the Nevada Advisory Council on Federal Assistance
- Oversee a Statewide Grant Management System

Federal Assistance Notification Form (FANF)

- State agencies are required to report to the Nevada Grant Office at each step of the federal grant award lifecycle, including:
- Intent to Apply
- Grant Award/non-award
- Post-award amendments
- Close Out

Regulatory Authority

- Executive Order 12372 (often cited in federal funding applications)
- NRS 232.225
- SAM 3000

Federal Assistance Notification Form

The Importance of Reporting

- Allows for the Office of Federal Assistance to compile the data as directed by AB445 and the Governor's Office
- Increases collaboration and duplication of efforts
- Streamline processes and remove barriers
- Provide transparent, accurate data regarding federal assistance



Federal Assistance Notification Form

How to Report

- Complete the Federal Assistance Notification Form (FANF)
 - https://ofa.nv.gov/
- When?
 - Your agency has these following FANF triggers:
 - Intending to Apply for a Grant
 - Received a Grant
 - Amended a Grant
 - Close Out of a Grant
- Remember
 - The FANF complies with the State of Nevada Grant Policy Single Point of Contact (SPOC) 088-GP 04 Intergovernmental Review of Federal Programs requirements (E.O. 12372)



Notice of Funding Opportunities

- Notify the Office of Federal Assistance regarding a funding opportunity of your agency
- Complete the easy Notice of Funding Opportunity (NOFO) located on the Office of Federal Assistance website
 - https://ofa.nv.gov
- This information is then posted on the Office Federal Assistance website

Coming Soon!

- Improved notification of the NOFO's reported to interested stakeholders
- Improved highlighting of NOFO's on website



Grant Matching Program

Originally known as the Grant Matching Fund pilot program

Became a permanent program with the passage of AB445

Program Details

- Grant Matching Program is available for state agencies, local agencies, tribal governments, and nonprofits applying for federal funds, who need matching funds for the federal grant they are pursuing and have exhausted all efforts to find available funding, prior to the awarding of the federal grant.
- The program awards cash grants to satisfy up to 50% of the required match necessary to receive federal funding awards.
- Funding available: \$1 million per Fiscal Years 2022 2025

US Digital Response — Pilot Program

- Challenges of identifying federal grant opportunities and increasing collaboration
- The Office of Federal Assistance has launched a pilot program with the members of the Infrastructure Subcabinet to utilized a federal grant opportunity finder software tool, US Digital Response (USDR)
 - Dashboard which highlights the grants your agency is interested in applying for;
 - Ability to see if other state agencies are interested in the same grant (collaboration!);
 - Ability to classify those federal grant opportunities
 - Allows for the Office of Federal Assistance to utilize the data to meet the requirements identified in AB445 for data collection and reporting
