It also will facilitate the obstetrics process for medical professionals by allowing the procedures to be done on-site instead of in a patient’s home or a third-party location. This new Mesquite Women’s Clinic will provide safe obstetrics and gynecology services in Mesquite at a reduced cost and provide out-patient gynecologic surgical services, which will be a significant cost-saver for patients and the clinic. Mesquite Women’s Clinic has long-term goals of expanding to pediatric care. The new Mesquite Women’s Clinic will be a premier site in that the practice will offer a unique experience that improves easier access to perinatal care. The practice will improve pregnancy outcomes within the disparate population. Doctors and patients won’t need to travel long distances for childbirth and reduce the incidence of unsafe home births. Facility fees will be cut by 50% when outpatient surgical services are operated in the new facility. Mesquite Women’s Clinic offers both a private and public health focus in that care delivered will be the highest quality of women’s health services available. Mesquite Women’s Clinic’s purpose is to provide complete, compassionate, comprehensive health care. The company strives to put the care back into healthcare.
